

Local Government Parks and Recreation Services 2001

The Local Government Parks and Recreation Services surveys were mailed in spring and summer 2001 to the Chief Administrative Officers in municipalities with populations 10,000 and over and to the Chief Administrative Officers of counties with populations 50,000 and over. Of the 3,329 municipalities and counties that received surveys, 1,778 responded (53.4%).
