ICMA'S EMO INITIATIVE

WHAT DO WE MEAN BY ECONOMIC MOBILITY AND OPPORTUNITY?

- Economic success. When a person has adequate income and assets to support their and their family's material well-being.
- **Being valued in community.** When a person feels the respect, dignity, and sense of belonging that comes from contributing to and being appreciated by people in their community.
- **Power and autonomy.** When a person has the ability to have control over their life, to make choices, and to influence larger policies and actions that affect their future.

Urban Institute, Upward Mobility Framework





PEER LEARNING COHORT BASICS

- 15 local governments; 2 participants per local government
- Two in-person convenings, travel expenses paid

 First in-person convening in Washington, D.C. on June 26-28, 2024
 Second in-person convening in January 2025, location TBD
- Monthly virtual check ins
- Access to additional virtual and/or in-person learning opportunities
- \$20,000 grant to implement an economic mobility assessment, planning, engagement process, or other project





WHO SHOULD APPLY

- Applications must be submitted by U.S. local government entities and identify a team of two participating representatives.
- Teams must include the local government's chief administrative officer (CAO) or assistant chief administrative officer (ACAO).
- Other project team members may include additional staff, elected officials, chamber members, representatives of other community partners, etc.
- Teams must include at least one ICMA member
- No restrictions for local government size or demographics
- While extensive prior experience is not required, we are looking for indications of willingness to grow and apply learnings from this cohort even if you are currently still building capacity.





SELECTION CRITERIA

- Applications will be reviewed to create a well-rounded cohort representing geographic, demographic, and economic diversity across the participating local governments. Additional evaluation criteria include:
 - $_{\odot}$ Strength of participation team/staff capacity
 - $_{\odot}$ Projected impact of participation
 - Demonstrated commitment to improving economic mobility and opportunity for their residents.
- Upon selection, local governments will be required to submit a completed W-9, a vendor application with contact and tax information, and a brief due diligence questionnaire on local government activities and finances. Funding for travel to the June in-person cohort meeting may not be disbursed until this paperwork has been received.

- Local government demographic info and participant info
- How your local government currently prioritizes economic mobility, if applicable
- Current challenges or barriers to upward economic mobility within your community
- Focus areas for your local government's proposed work
- How your local government would spend the \$20,000 in grant funds to address economic mobility and opportunity within your community
- What you hope to gain from participating in this cohort

USE OF GRANT FUNDS

- Typical projects include an assessment, planning, or engagement process related to one or more economic mobility and opportunity themes.
- Focus areas could be comprehensive and/or targeted to issues such as workforce housing, childcare access, community health, neighborhood cleanup, broadband access, etc.
- Eligible costs would typically include:
 - Core personnel
 - Consultants for facilitation, planning, data collection and analysis
 - Stakeholder engagement with community organizations, residents, and other partners
 - Costs associated with early implementation of an action plan
- Award of funding is subject to a final project budget and scope of work approved by ICMA



ICMA invites local governments to apply for the 2024 Economic Mobility and Opportunity (EMO) Peer Learning Cohort and grant program. This is a unique networking opportunity for ICMA members to receive training, coaching, and funding to effect conditions that promote overall well-being and upward mobility of their residents. ICMA will select teams from up to 15 local governments to make up the 2024 EMO Cohort. Esch selected local government will receive a grant of 520,000 for the implementation of an economic mobility assessment, planning or engagement process, or other local activity as part of their participation in the cohort. This opportunity is made possible with support from the Bill & Melinda Gates Foundation. Brief applications are being accepted now through May 10.
