# WHAT DO WE MEAN BY ECONOMIC MOBILITY AND OPPORTUNITY?

- Dignity and belonging. When a person feels the respect, dignity, and sense of belonging that comes from contributing to and being appreciated by people in their community.
- Economic success. When a person has adequate income and assets to support their and their family's material wellbeing.
- Power and autonomy. When a person has the ability to have control over their life, to make choices, and to influence larger policies and actions that affect their future.

# PEER LEARNING COHORT & GRANT OPPORTUNITY





#### PEER LEARNING COHORT BASICS

- 15 local governments; two participants per local government
- \$20,000 grant for an EMO centered project
- Two in-person convenings, travel expenses paid (\$4,000)
- Monthly virtual check-ins and trainings



#### **APPLICATION EXPECTATIONS**

- U.S. local government entities and identify a team of two participating representatives
- Teams must include the local government's chief administrative officer (CAO) or assistant chief administrative officer (ACAO)
- Teams must include at least one ICMA member





#### **USE OF GRANT FUNDS**

- Assessment, strategic plan, or engagement process
- Focus areas such as childcare access, community health, workforce housing, neighborhood cleanup, broadband access, etc.
- Eligible costs would typically include (but not limited to):
  - Core personnel time
  - Consultants
  - Community engagement
  - Costs associated with implementation of an action plan





#### **APPLICATION CONTENT**

- How your local government currently prioritizes economic mobility, if applicable
- Current challenges or barriers within your community
- Anticipated focus areas for your local government's proposed work
- How your local government would spend the \$20,000 in grant funds

#### **SELECTION CRITERIA**

- Strength of participation team
- Staff capacity
- Projected impact of participation
- Demonstrated commitment to improving economic mobility and opportunity for the community





### **CONTRACT REQUIREMENTS AND CONTENT**

- Expect that this process will require a quick turnaround time to ensure proper participation
- Upon selection, local governments will be required to complete the ICMA subgrant agreement process
- Grant funds will be dispersed in two payments:

Payment 1: \$19,000, Anticipated July 2025

Payment 2: \$5,000, Anticipated December 2025
