


# Highlights of the 2024-2025 Cohort

### **Rachel Boward**

Loudoun County, Virginia LGMF Fellow 2024-2026

#### **FELLOWSHIP PROJECTS**

- 1. Updating the International Business Attraction Plan for Loudoun's Economic Development Department.
- 2. Created mentor and mentee guides for the LEAD Loudoun program, and a leadership structure guide for the Mental Health, Substance Abuse, and Development Services Department.
- 3. Helped track bills during the state legislative session and assisted in updating Loudoun's federal legislative program.
- 4. Assisted the Library Department with strategic plan updates, staffing analysis, and a secret shopper program.

#### What was the highlight of your fellowship?

The highlight of my fellowship so far has been going to so many great conferences. In only nine months, I've gone to the Esri Federal GIS Conference in D.C., NACo Legislative Conference in D.C., VACo County Government Day in Richmond, ICMA Local Government Reimagined Conference in Milwaukee, and ICMA Annual Conference in Pittsburgh!   Budget and Management Services
  Office's user fees project,
  compiling departmental fee data
  across comparable jurisdictions to
  support ongoing cost recovery and
  service evaluation efforts.
- 2. Supported the development of performance dashboards using Power BI, which allowed departments to better visualize key performance indicators and align their operational goals with countywide strategic priorities.
- 3. Collaborated with internal stakeholders to analyze operational trends and worked closely with the performance team to translate data into actionable insights.

#### What was the highlight of your fellowship?

#### **FELLOWSHIP PROJECTS**

1. Economic Development RFP -Marketing and Branding Strategy, where I drafted RFP criteria, intranet updates, scoring rubric, and debriefs, and contacted potential vendors and panel members. I also conducted panel interviews and sent recommendations to DCM.

#### What was the highlight of your fellowship?

## **Kayla Hickey**Bakersfield, California

Bakersfield, California LGMF Fellow 2024–2025

#### **FELLOWSHIP PROJECTS**

- Implemented banners for an informal renaming of a street that includes six veterans memorials. I worked with the Kern County World War 2 Veterans Committee, our communications and marketing team, and the development services team to allow for the vision to come to life.
- Conducted research on the development of a Tree Advisory Group and a new tree contract for the management of the city's urban forest.
- 3. Collected data from many
  California municipalities on the
  Tree Advisory Group's structure
  and function, along with data
  on best practices in urban forest
  management contracts. I was
  able to provide this research to
  the recreation and parks director
  for his use in creating the Tree
  Advisory Group and for use when
  going out to bid for the next urban
  forest management contract.

#### What was the highlight of your fellowship?

The highlight of my fellowship was working on the city's Comprehensive Climate Action Plan, also known as Sustainable Opportunities Advancing Resilience (SOAR Bakersfield). Engaging with our staff across departments and with our community, stakeholders, and advisory groups was extremely enlightening. I was able to understand the concerns of the residents throughout the community engagement process.

#### What advice would you give to an incoming fellow?

Always ask to be included on projects that interest you! Additionally, when it comes to assignments offered, never say no. Whether you are interested or not in the subject matter, exploring new areas will allow you to learn and develop in your career.

#### What are your next steps when the fellowship ends?

I accepted a role as an economic and community development planner with the city of Bakersfield, California. Within this role, I will be responsible for administering and managing a \$22 million-dollar Transformative Climate Communities Grant that the city received from the Strategic Growth Council.





## **Zoe Johnson** Edina, Minnesota LGMF Fellow 2024-2026

#### **FELLOWSHIP PROJECTS**

- 1. Edina U: This was Edina's first general government education series for residents to learn all about the various functions of their local government. This low commitment opportunity has already been highly praised by the community and residents have already started to question if there are more opportunities similar to this program that could be added as more people "graduate" from Edina U's 101 courses.
- 2. Human Services Task Force: I facilitated a volunteer task force of community members interested in assisting the city with analyzing current human services funding levels and funded organizations, which included conducting site visits, helping eight nonprofit organizations create work plans that aligned with both the organization's and the city's values, and providing the city council with an update that gives a recommendation for next year's funding levels and funded organizations.
- 3. Equity Strategic Action Plan: I helped the DEI manager for over six months work with culture brokers to develop the ESAP to better inform the city's goals of creating an inclusive and welcoming community with minimal barriers to city programs, services, and policies that benefit the Edina community.

#### What was the highlight of your fellowship?

Conferences hosted by member organizations like ICMA, MCMA, and the League of Minnesota cities. These conferences were excellent for providing educational and career growth opportunities/activities, encouraging networking with other local government professionals, and of course, just getting out of a routine and experiencing some new things and places to recharge and relax.

#### What advice would you give to an incoming fellow?

These fellowship positions are your best opportunity for learning as much as you can by getting out and about to shadow different positions, ask tons of questions, and be part of and/or lead projects that will help you blossom into an amazingly well-rounded public servant. Do not take this title for granted and bring the energy to show those around you why you are here! While people may confuse you with interns, hold firm and remind those around you that this position is specific to learning about strong public administration. Each day holds new adventures—take them in stride.

#### What are your next steps when the fellowship ends?

While I plan to stay well connected to my current supervisors and other fellows that were in Edina before me. I plan to leave the metro area and find a small community to work and live in with my partner. I am hoping to find a city administrator position somewhere in north/central Minnesota.

#### What was the highlight of your fellowship?

The opportunity to be surrounded by local government professionals and have unhindered access to all aspects of the city.

#### What advice would you give to an incoming fellow?

Make the fellowship yours and be available to people. You get the most out of your fellowship when you broaden your horizons and work on challenging projects that you have little to no information about.

#### What are your next steps when the fellowship ends?

I will continue working for Wichita as a management analyst in economic development.





## **Anna Le** Tacoma, Washington LGMF Fellow 2024-2026

#### **FELLOWSHIP PROJECTS**

- 1. Coordinated the city's new process for conferring honorary place names. I led the effort to rename a park, and it was the first time the city conferred a place name in honor of a Black woman.
- 2. Managed resources, files, and materials for the city's decennial charter review process, ensuring the city council had what they needed to revisit our jurisdiction's guiding legal document.
- 3. While serving as the commission liaison, the Mayor's Youth Commission held a children's and young adult book drive, which collected nearly 3,000 books that will be distributed to community partners, including the juvenile detention facility, public benefits offices, youth shelters, and community centers in low-wealth/ low-income neighborhoods.

#### What was the highlight of your fellowship?

I had the rare privilege of viewing my beautiful hometown from the top of a crane in the Port of Tacoma.

Also, the LeMay Car Museum opened over 12 years ago in Tacoma but was the only institution that did not participate in our library system's museum pass rental program. I was part of the process of making this opportunity available to library patrons.

I graduated from the Washington City-County Management Association's Northwest Women's Leadership Academy.

#### What advice would you give to an incoming fellow?

You have so much to learn from your colleagues, regardless of the position they hold and whether or not you plan to work in your current jurisdiction long-term.

#### What are your next steps when the fellowship ends?

I just started my first, six-month department rotation earlier this week. I'm the first of my city's 18 fellows to do my rotation with the Fire Department. During my rotation, I'll be analyzing internal policies, response data, citywide resources, and national standards to identify ways to divert low-acuity calls to more appropriate responses outside of the fire department.





## Lily Meadows

Wichita, Kansas LGMF Fellow 2024–2025

#### **FELLOWSHIP PROJECTS**

- 1. Served as the project manager of a municipal ID project.
- 2. Created a social media page for the animal shelter and was able to speak at the mayor's weekly media briefings to educate the public.
- 3. Wrote two city-wide policies.

#### What was the highlight of your fellowship?

Speaking at city council for a municipal ID ordinance where it passed unanimously. I was so proud to see my hard work pay off and know that the citizens of Wichita will benefit from this program for many years.

#### What advice would you give to an incoming fellow?

Get as involved you can, know you belong, and ask for help/explanations.

#### What are your next steps when the fellowship ends?

I will be working for the city of Key West as a planning project coordinator.





## Harrison Netburn Pinellas County, Florida LGMF Fellow 2024-2026

#### **FELLOWSHIP PROJECTS**

- 1. Worked across diverse county departments including Emergency Management, Public Works, and the Office of Budget and Management. These rotations have given me firsthand experience in policy research, project coordination, and legislative analysis.
- 2. During Hurricane Milton, I served as a shelter manager at Largo High School, where I led a cross-functional team and partnered with school and law enforcement officials to ensure public safety and efficient operations.
- 3. In Public Works, I facilitated workshops to enhance the county's project management process and led efforts to secure emergency funding from the National Resources Conservation Service.
- 4. In the Office of Budget and Management, I have been serving as the operating budget analyst for the St. Pete-Clearwater International Airport (PIE). In this role, I have reviewed and analyzed PIE's operating budget and presented the analysis to the county administrator and the county commission.

#### What was the highlight of your fellowship?

Working as a shelter manager during Hurricane Milton. This experience was like no other and showed me how the county can make a real difference.

#### What advice would you give to an incoming fellow?

I would advise a new fellow to be curious and ask questions. This experience is what you make of it. It is special to be in this kind of position, so learn as much as you can!

#### **FELLOWSHIP PROJECTS**

- 1. Administered special event grant funding for community nonprofit organizations.

- 3. Managed the main information email inbox for the city, providing customer service and directing inquiries to staff, as well as managing the city's community calendar of events.

#### What was the highlight of your fellowship?

#### **FELLOWSHIP PROJECT:**

- 1. Hosted the first Earth Day arts exhibition in collaboration with our Climate and Sustainability Department. The exhibit focused on sparking a discussion with our residents regarding climate change and its impact on central Pennsylvania.
- 2. Hosted an exhibition in collaboration with our business district and the Department of Diversity, Equity and Belonging, which encouraged our residents to share what the holiday season meant to them. We focused on expressing the variety of cultural holidays that our residents celebrate within State College.
- Collaborated with three of our surrounding municipalities and our climate and sustainability team to develop a single-use plastic ordinance.
- Developed an implementation plan, community engagement strategy, and communication roll out. This project has taken more than 2 years, and we hope to begin implementation in late 2025.

#### What was the highlight of your fellowship?
