



Our Vision: We envision a future for the Alexandria Area and Douglas County as the most vibrant regional center in the upper Midwest.

<u>Our Mission</u>: The mission of the Alexandria Area Economic Development Commission is to drive the economic wealth and stability of our communities.

Our Core Values:

Stewards - Build a strong coalition for action to support economic and community growth for our area. **Trust** - Earning and sustaining the trust of our businesses, communities and elected leaders we serve. **Inclusiveness** - Work to promote the prosperity of the region.

Nurturing - Empower and educate our communities and our leaders.

Respect - Admiration for our natural resources and embracing the opportunities they provide.

The mission of the Lakes Area Economic Development Authority is to support the mission of the Economic Development Commission by providing fair and equitable resources. The Authority, fully implemented in 2004, was established to formalize the funding for economic development and to bring the political subdivisions together for a unified economic development effort.

In 2009, the AAEDC focused on the following key areas of service:

- Business Planning

The AAEDC works with a large variety of businesses and individuals in the business planning process. Since no two business ideas are the same, and no two businesses or ideas are at the same point in the planning process, business planning assistance is tailored specifically to the individual's or business's needs.

- Demographics Information

The AAEDC strives to be a demographics, statistics, and information clearing house for our area and produces multiple publications each year focusing on the growth and changes of our communities and all of Douglas County.

- Site Selection Assistance

In a continuously growing effort to assist area realtors and property owners to market commercial properties throughout the area, the state, and the nation, the AAEDC maintains two supplemental property listing databases of "for-sale" and "for-lease" properties. These databases are free for the listing of commercial properties in Douglas County, and can be easily accessed by individuals, businesses, and site selectors from throughout the nation.

- Commercial Tax Incentives

The AAEDC works with new and existing businesses on startup and growth projects, some of which can be supported through incentive programs, including: Tax Increment Financing (TIF), Tax Abatement, Industrial Revenue Bonds, and the State of Minnesota's Job Opportunity Building Zone (JOBZ) program.

- Revolving Loan Funds

In addition to commercial tax incentives, the AAEDC has a pair of Revolving Loan Funds at its disposal to assist area businesses with growth and expansion projects. Funds are specifically used in coordination with primary financing through a financial institution and cannot be used as the primary means of project funding.

- Financial Packaging

As a part of business planning, the AAEDC helps individuals and businesses to create and analyze financial projections to identify potential needs of the business. Within the financial packaging and planning process, the AAEDC does not recommend any specific commercial lending institution(s) to clients.

- Community Stewardship

In today's changing economic environment, it is becoming more important than ever to maintain cross-organizational communication and a 360 degree vision for the future of our region. The AAEDC is continuously working to be a convener of communication on the future of our communities and region.

Funding provided by the Lakes Area Economic Development Authority (LAEDA) whose membership is comprised of the City of Alexandria, City of Garfield, Alexandria Township, and LaGrand Township; with supporting annual appropriations from the Townships of Brandon, Carlos, Hudson, Lake Mary, and Douglas County.





At the close of FY 2003, Governor Pawlenty unveiled the Job Opportunity Building Zones (JOBZ) program as a new rural Minnesota economic development plan. The goal of JOBZ is to stimulate economic development in rural Minnesota by providing local and state tax exemptions to offer assistance to value-added manufacturing and industrial, or high wage service-type businesses. Retail and housing projects are not eligible to receive JOBZ benefits.


Local entities participating in the JOBZ program include the Cities of Alexandria, Brandon, Garfield, and Osakis; and the Townships of Carlos and LaGrand. Designated industrial sites in these areas offer growing and expanding businesses the opportunity to substantially benefit from tax exemptions through December 31, 2015.

Tax exemptions apply only to qualified businesses. Businesses will become qualified for JOBZ through the execution of a Business Subsidy Agreement (BSA). On an annual basis the company must report to the MN Department of Employment & Economic Development and local units of government their progress in creating jobs and wages.

COMPANY: DOUGLAS SCIENTIFIC/DOUGLAS MACHINE INC.

Douglas Scientific/Douglas Machine, Inc. of Alexandria has completed a 26,000 sq. ft. expansion to their facilities in the Alexandria Industrial Park, which will provide clean space/laboratory space for research and development of the company's Douglas Scientific division and additional space for the company's core manufacturing functions. This expansion will create an additional 12 new positions within the company and had a total project cost of \$1.6 million. The AAEDC assisted Douglas Scientific/Douglas Machine Inc. with applying to the City of Alexandria for Tax Increment Financing (TIF) benefits to help offset infrastructure costs.



COMPANY: LAKEWOOD TERRACE, LLC

Lakewood Terrace, LLC will be constructing two multi-family housing facilities on South Broadway in Alexandria, totalling 50,000 sq. ft. with a total estimated project cost of \$5.2 million. Each facility will contain 18 housing units The project is scheduled for completion in August of 2010, and will result in the employment of 2 full-time and 4 part-time individuals. The AAEDC has assisted Lakewood Terrace, LLC with applying for Housing Tax Increment Financing (TIF) benefits from the City of Alexandria to assist with the cost of the project's infrastructure. In return for these benefits, the developer will commit 20% of the units to individuals/families who's income is 50% or less than the area's median gross income.

COMPANY: LIFELINK III

LifeLink III, a leader in ground and air medical transportation, has selected Alexandria as the location of a new air base for emergency medical transportation servicing West Central Minnesota. As part of this location, LifeLink III will station at least one helicopter in Alexandria at all times. For a severely sick or injured patient, the presence of an emergency transport helicopter in the community will significantly decrease the time required for a patient to arrive at a specialty care facility in a metropolitan area. LifeLink III's presence in the community is a valuable addition to the region's growing medical hub.

As part of this project, LifeLink III will be sub-leasing existing hanger space from Weber's Aero Repair at Alexandria's Chandler Field, and will be placing a 1,200 sq. ft. office and personal quarters for medical staff and administrative functions on the property. To support the Alexandria base, LifeLink III will be employing approximately 15 people, including pilots, Registered Nurses, maintenance personnel, and Emergency Medical Technicians.

COMPANY: STEUSSY DIESEL, INC.

Steussy Diesel has completed construction of a 6,800 sq. ft. building expansion in Hudson Township. Steussy Diesel offers a complete medium and heavy duty truck/trailer repair facility, a Goodyear tire and alignment facility, heavy duty truck and trailer towing, tire repair roadside assistance, mechanical roadside assistance, and a full service shop with a full like of truck parts. The additional facility space will allow the company to expand is parts and storage ability and to increase its engine repair services. Steussy Diesel currently employs 10 individuals and will be hiring 3 additional employees in coordination with this project.

COMPANY: LEGACY OF ALEXANDRIA

Phase 1 of the 2 phase Legacy of Alexandria, 116 unit multi-family apartment complex in Alexandria has been completed. Construction was finished on 62 units during 2009 and the remaining units will be constructed during 2010. The entire project has a total estimated cost of \$10 million and will result in 165,845 sq. ft. of new construction. The AAEDC assisted the developer (INH Property Management) with applying for and securing Housing Tax Increment Financing (TIF) from the City of Alexandria. In return, the developer will commit 20% of the units to individuals/families who's income is 50% or less than the area's median gross income.

COMPANY: RIVERSIDE SUPPLY, INC./POWERS MACHINING, INC.

The AAEDC staff providing assistance to Riverside Supply Inc./Powers Machining Inc. in applying for Tax Increment Financing (TIF) benefits from Douglas County for their new 16,000 sq. ft. facility in Carlos Township.

Riverside Supply is a customer focused company supplying fasteners and consumables to the manufacturing and assembly industry.

Powers Machining provides CNC milling and turning and conventional milling and turning to their clients, specializing in machined weldments, prototype work and short run production, and mold machine presses.



Special thanks to the Alexandria Lakes Area Chamber of Commerce for their significant assistance with the distribution of this publication.






Douglas County Manufacturers & Support Industries Directory


AAEDC Financial Assistance Guide

Destiny Driver Measures Identified:

The Alex Area Stewards initiative has completed its second year of "Working to Unite Our Region for a Vibrant Future." The Stewards have joined with organizations throughout the Alexandria Regional Community to share information, insights, and resources to benefit our entire regional community and to build upon our 12 Destiny Drivers.

SPECIFIC EFFORTS IN 2009 HAVE INCLUDED:

Regional Community Meetings:

- To gain a better understanding of the shared efforts and challenges of communities throughout the region and to increase cross-community communication and collaboration, the Stewards have undertaken an initiative to meet with community and business leaders from our area's smaller towns. Leaders from each visited community are asked to attend the meeting to discuss activities and challenges along with ways that organizations and elected officials can work together more effectively.

Alexandria Technical College Law Enforcement Center Grand Opening:



On September 25, 2009, Alexandria Technical College hosted a grand opening for the new 59,000 sq. ft., \$10.4 million ATC Law Enforcement Training Center. This state-of-the-art facility will house the ATC Law Enforcement program, and will provide excellent skills training facilities to law enforcement agencies from throughout the region and state. Included in this facility is an indoor firing range, dispatch center, crime scene investigation laboratory, tactical warehouse, and classrooms. The Law Enforcement Program is one of the signature programs of Alexandria Technical College and the new facility marks the College as one of the premier training facilities in the northern plains states.

ALEXANDRIA TECHNICAL COLLEGE - MINNESOTA JOB SKILLS PARTNERSHIP GRANTS:

KNUTE NELSON

Alex Tech received a \$49,752 Minnesota Job Skills Partnership Grant with Knute Nelson to train 30 employees. The project will provide an innovative training experience targeting the needs of extended care for the elderly using simulation based training. Alexandria Technical College will develop a comprehensive package of simulation scenarios tailored to the care needs of the elderly population at Knute Nelson.

DOUGLAS MACHINE

Alex Tech received a \$276,329 Minnesota Job Skills Partnership Grant with Douglas Machine to train 84 employees. This project will expand upon the Remote Automation Management Platform at Alexandria Technical College to provide distance-based training that will utilize real software and hardware – not just simulations. This concept has been branded the "LongWire" training platform. The training will allow technicians to receive education that will assist Douglas Machine to remain an industry leader as they continue to face competitive challenges from an increasingly global marketplace.

ALEXANDRIA PRO-FAB COMPANY

Alex Tech received a \$167,521 Minnesota Job Skills Partnership Grant with Alexandria Pro-Fab to train 80 employees. This project will provide focused training in the areas of: CNC Operation, CNC Set up, CNC Programming, Continuous Improvement, and Total Quality Management. This training will allow Alexandria Pro-Fab Co., Inc. to develop new skills that will aid in their continuous pursuit of workforce excellence.

DOUGLAS COUNTY HOSPITAL EXPANSION:

Douglas County Hospital has made significant progress on a new 100,000 sq. ft. addition to their facility which will be operational in the summer of 2010. With a total estimated cost of \$30 million, this expansion will include a 3-story addition on the south side of the current facility with space for Heartland Orthopedic Associates, P.A., additional inpatient rooms, and an Obstetrics Unit. The project costs are being financed through Douglas County Hospital savings and the issuance of tax-exempt revenue bonds. No tax payer dollars are being used to finance this project.



Douglas County Hospital is one of only eight County-owned

hospitals remaining in Minnesota, and has been recognized as one of the "Top 100 Hospitals" in the nation in both 2002 and 2008. Douglas County Hospital was selected from amongst 3,000 peer hospitals based upon hospital-wide performance in five clinical areas.
