

City Jail Reopening.

The City of Hoquiam closed its jail in 2002 due to budget cuts. It took 10 years to get reopened. But, it could have never happened without a unique partnership.

The partnership was conceived in 2012.

3. How exactly is the program or policy innovative? How has your innovation changed previous processes, products or services? *100 word maximum*.

Reopening the City jail is innovative because it used existing capacity to solve incarceration problems for two agencies. The Washington State Department of Corrections needed a place to house "low-risk" parole offenders and the City needed a way to fund their jail.

This innovative effort allowed us to pay for the operation of the City Jail. But more importantly, it gave the Police Department back the tool they needed to ensure that citizens are safe and that high risk offenders are locked up.

4. Explain how the program or initiative substantially stretched or improved the boundaries of ordinary governmental operations. *200 word maximum*.

Reopening the City Jail stretched ordinary government operations by continually bringing in money from outside the City to operate our jail. It did not take a tax increase. The jail could never have been opened on a full time basis within the current budget. However, by bringing in a steady stream of prisoners from an outside agency it provided the necessary funding to operate the jail. Funding is sufficient today to pay for all of the costs of operating the jail and even allows us to house all of our City prisoners.

5. What individuals or groups are considered the primary initiators of your program? How does the innovation engage stakeholders or demonstrate high performance teaming? Were strategic partnerships and/or community networks developed as a result of the innovation? 200 word maximum.

The Police Department deserves all of the credit for initiating this program. They worked tirelessly to find ways to get the jail reopened. But, it wasn't until the Washington State Department of Corrections came to look for ways to house prisoners that it could be done. Most importantly, the Police Department staff continued to maintain the Jail for over a decade in hopes that it could be reopened. So, when it finally came time to open the doors the facility was ready to go.

When offenders are held accountable, citizens feel safer. This unique partnership has provided so many benefits to both the State and the City. We are truly excited about this opportunity and

believe it should be a model that can be replicated throughout the State. Word of the "Swift and Certain" program has even reached as far as the White House. President Obama has stated that he wants to expand this probation model and use it as an example to reform probation and parole.

8. What were the costs? What were the savings? 100 word maximum.

In 2014, the Hoquiam City Jail cost \$485,000 to operate. However, the City billed the Washington State Department of Corrections \$440,000 for housing of prisoners resulting in a net cost of \$45,000 to operate the City Jail. In previous years it cost the City \$90,000 to house prisoners with other agencies. Therefore, the savings are \$45,000 per year.

9. Please describe the most significant obstacle(s) encountered thus far by your program. How have they been dealt with? Which ones remain? *200 word maximum*.

The most significant obstacles have been (1) developing a billing system with the Department of Corrections and (2) keeping up with demand for women parole offenders. As this was a new programs, the City needed to develop a process so that bill were submitted timely to the State of Washington. The City now had 5 new employees to pay and needed the reimbursement from the State of Washington to fund this program. Staff was able to determine when bills were due to the State's AP Department and what would be acceptable and the money began flowing in.

The City's Jail is set up to house 10 men and 4 women. However, we have quickly found out that there are just as many women parole offenders as men. Therefore, the City has begun to look at expansion plans for the current jail to house 18 men and 11 women.
