
# Asian Pacific American Affinity Group

Interests and Priorities



#### Background

- One of ICMA's Core Beliefs is to ensure that local governments and the association reflect the diversity of the communities we serve
- Recent estimate is that less than 1% of ICMA full members are Asian
- At the request of several members, ICMA has supported exploring needs and interest in building a network of Asian Pacific American (APA) local government professionals

### Background (cont'd)


- This Spring, ICMA distributed a survey to 335 members self-identifying as APA or serving significant APA populations. Involved members also distributed the survey to our networks
- 75 individuals responded for a response rate of 18%, or slightly lower given non-member responses

#### 2016 ICMA APA Survey

- Purpose
  - Identify interest areas, needs and priorities of APA members
  - Gauge interest and encourage participation in an ICMA affiliate group

### Survey Results (cont'd)

- "Other" suggested activities
  - Providing support to APA women
  - Establishing online resources specific to the APA community
  - Involving APA members in the international development work that ICMA conducts
  - Strengthening local networks
  - Recruiting APA individuals

## Survey Results (cont'd)

#### Other Comments

- "I have been a member for over 40 years. I am happy to see some interest in APA issues."
- "I think this effort is great. I think it may be beneficial to start at the state level."
- "I have not considered attending an ICMA conference, but I would likely consider it if there was an APA networking event at it."

#### **Immediate Opportunities**

- ICMA is very willing to support development of an APA affiliate group
  - Could simply start with establishing "membership" in a group, no dues requirement
  - Over time this could evolve into outreach and fiscal support, co-sponsorship of events, etc.
- There are ongoing initiatives (such as diversity and inclusion) that seek APA involvement, but currently have no organization to engage

### Opportunities (cont'd)

- A "Group" is needed to establish a functional communication network and setting a course forward
- ICMA's Annual Conference is a key opportunity to advance discussion in person

#### **Proposed Next Steps**

- 1. Use a LinkedIn Group as initial "membership" and communication platform for an ICMA/APA Affinity Group
  - Membership open to anyone; ICMA membership not required
- 2. Identify a steering/leadership committee (five-person) to propose the following for approval by the Group:
  - Organization name
  - Mission/vision statement
  - Workplan
- 3. Empower the volunteer committee to work out details and make this happen
