 - For example, El Paso County, TX, has provided data; the City of El Paso is now aligning their data collection around the 80 KPIs.

ICMA facilitates software-neutral benchmarking that puts cities and counties in the driver's seat.

Cities and counties routinely report on their own performance year to year, and many also compare their metrics with the community next door. But how can they tell if they're really performing as well as they could—or whether they're comparing apples to apples?

ICMA's approach to local government performance benchmarking simplifies the process by zeroing in on key indicators and providing agreed-upon definitions that help ensure meaningful comparisons. And it's free of charge.

- 80 Key indicators with consistent definitions
- More than 15,000 data points available
- Compare with others or year-to-year trends
- No specialized software and no charge

- Certificate program
 - 2018: 57 recipients, plaques being mailed
 - Sample documents are posted online

<p>What Holds Others Back?</p> <p>Challenges include deciding on key metrics and collecting comparable data. For smaller organizations in particular, staff time is precious.</p> <p>To jumpstart your implementation, look to the key definitions and data posted at icma.org/benchmark. Staff can focus on just 80 key performance indicators (plus 54 specific to counties).</p> <p>Access to the data is free of charge and there are no software requirements.
