# Cup of Joe to Go

I hope all is well with everyone's summer. I recognize that summer is the time where getting all the right people around a table for a topic is additionally challenging due to much needed vacations for staff, elected officials, citizens and business leaders. For those who meet with school officials, meeting availability can be further constrained as many school administrations are closed on Fridays. There are some recurring monthly meetings I have with groups that everyone in the group may not be together until September.

It also may be the time for where your locality reduces their twice/month boardcouncil meetings to once in July and August. For those that plan out future meetings twice/month, it may seem like you're already starting the agenda preparation and review process for the next meeting as soon as you finish the previous meeting. Enjoy the additional time between meetings this summer. Beginning in 2017, Chesterfield continued the once/month meetings throughout the year; except for the additional budget meetings in March and April. It has enabled us to focus all of our attention to the most relevant topics that provide time for elected official and citizen input prior to the meeting. I liken the elected officials meeting to a one-day only production where every topic has relevance, all facts need to be known and communicated, all questions need to be answered, and all presentations need to be professional and understood by the varying audiences in the room. There may be many rounds of refining the narratives and perfecting the presentations to anticipate as much as possible. There is little time to reflect, but rather actions needed to make the next meeting the same degree of professionalism, if not better.

The summer may also be the time where the chief administrative officer (CAO) goes through a closed session as part of their annual review. This may include review of accomplishments, prior and new fiscal year priorities, or quite frankly any topic for which the role of the CAO may have been or should have been part of the equation. For many localities, that expectation may be for 100% of the topics. Therefore, these closed sessions may go down many different paths. Hopefully, for those that go through this exercise, it is a productive use of time for you and the elected officials.

In any case, I hope all of you get to enjoy the summer and appreciate the coverage that your staff does as many in your organization enjoy their vacations and much needed time with family and friends.

# How do day dat?

My maternal grandfather, Opa, spoke English with a strong Dutch/German accent. When he wanted to know how something had been done, he'd say, "How do day dat?" (How do they do that?)

The other morning, as I do every day (bear with me), I walked to the end of my driveway at 5:00 am, picked up the Richmond

Times Dispatch, and turned to the sports section. The first headline to catch my eye read, "Long Balls, Long Game." Underneath were a color picture and a lengthy article about the 89th annual All-Star Baseball Game that had concluded at 11:58 pm the previous evening...just five hours earlier. Immediately, my grandfather's words echoed in my ear. "How do day dat?"

The magic required to write and edit an article, print the pages, assemble the sections, load the finished edition on trucks, get those papers to the carriers, and drop the paper onto my driveway in 5 hours or less boggle my mind. I needed to find out how it's done.

It wasn't that long ago when producing a newspaper involved a reporter typing on a manual typewriter and then a typesetter manipulating small metal blocks of words or combination of letters, setting up each page for the printing press. The process was labor and time intensive. Article deadlines had to be late in the afternoons to make the next day's morning edition.

Today, it's all about computers and offset printing. Articles and other content are now prepared digitally. That's not so surprising. The real trick is the printing process.

Almost all daily newspapers now use a process called web offset printing, which uses giant reels, or "webs," of newsprint and four colors of ink: cyan, magenta, yellow and "key" (black), usually abbreviated as CMYK. The artwork is imaged by laser onto aluminum printing plates, one plate for each color. The colors are printed onto the running web of paper, in sequence-from Cyan to Blackresulting in a complete full-color image. The separate webs of paper then come together and are slit, cut again, folded, stacked, and packaged. The whole process is fast. It typically takes less than 30 seconds from when the ink is applied to newsprint to when the finished newspaper is packed for distribution.

So now you know, "How do day dat." I really hope newspapers don't fade away. We need some magic in our lives. Contact Tedd Povar



Civic Engagement - Lynchburg Reducing Poverty Through Community Linkages

# Lynchburg Reducing Poverty Through Community Linkages

Civic Engagement continues to be a priority for VLGMA localities and requires people power. Engaging communities in social uplift to promote a better quality of life for all provides a sense of responsibility between citizens.

In the City of Lynchburg, a concerted effort to reduce poverty and raise the median household income has brought together many civic-minded individuals of diverse backgrounds. The movement, "From Poverty to Progress," is supported by City Council and was championed in 2017 by former Mayor Joan Foster and current Mayor, then Vice Mayor, Treney Tweedy. This initiative was born out of a realization that our civic engagement practices should involve all citizens despite varied socioeconomic status, census tracts and zip codes.



Background:

Lynchburg was designated a Bridges Out Of Poverty ©Community in late 2013 and the Bridges of Central Virginia (BOCV) group was formed. As the initiative moved on, the BOCV worked to develop plans that tackled Lynchburg's over 24% poverty rate. Lynchburg's City Council soon saw a need for more direct support from government to spur community involvement. In 2015, City Council commissioned a study to analyze this pressing issue; and in 2016 Council approved funding for and staff to better manage the City's priority of poverty reduction.

Beginning with a call to action from former Mayor, Joan Foster at the State of the City address in March of 2017, citizens were asked to be an integral part of the poverty reduction strategy in Lynchburg. A kick-off event for the newly minted "From Poverty to Progress" initiative was held in May of 2017 to engage the public, enhance support for ongoing programs, and flesh out definitive community concerns. Citizens of all ages, creeds, ethnicities, and incomes (many of whom may have not been at the same table otherwise) were now a part of a long-term collective effort to reduce poverty in the City of Lynchburg. This event began the process of developing action items focused on eliminating barriers for our low-income citizens. It was also a catalyst for the civic engagement of faith-based organizations, non-profits, individuals, businesses, schools, and others to rally around the cause of community uplift.



#### Current Events:

In 2018, Lynchburg continues to strive toward the mark of poverty reduction and increased median household income through civic engagement. The most recent Community Gathering held in June of 2018 marked a year of progress toward accomplishment of goals set by the workgroups. These projects include, but are not limited to: Early education tutoring assistance, building a grocery store in an identified food desert, creating an alliance to increase affordable childcare options, improving kindergarten readiness, developing easier access to health resources, implementing a community-subsidized transportation application, and revamping local public transportation. It is obvious that each of these items require an immense level of engagement, collaboration and cooperation!

Citizens have voiced a desire to be more civically engaged and involved with local issues. Through the Community Wealth Building Grant, Lynchburg's TechHire initiative and Getting Ahead program are forging the path toward self-sufficiency for many citizens. The Empower Lynchburg website was launched which offers a direct link between those who want to help and specific community needs. Also, our From Poverty to Progress groups and Bridges of Central VA groups are creating a symbiotic relationship based on active collaboration.

In summary, the success of this intensive movement could not be achieved without the engagement of Lynchburg's citizens. While official leadership comes from the City Manager's Office, the community linkages are pertinent and powerful. Community members have presented information to City Council, have addressed specific neighborhood concerns to administrative staff and have been thoroughly immersed in the workings of City government as a result of the From Poverty to Progress movement.

City management, local business owners, neighborhood groups, and many others have embraced the ideology of unselfish benevolence while directing the initiative toward a Thriving Lynchburg through civic engagement.
