

STAR: Equity & Empowerment

- 2014 STAR Rating in Equity & Empowerment was 54.7 points out of 100.
- Areas Measured:
 - Civic Engagement (10.6/15)
 - Civil & Human Rights (4/10)
 - Environmental Justice (6.2/15)
 - Equitable Services & Access (10.9/20)
 - Human Services (11.7/20)
 - Poverty Prevention & Alleviation (14/20)



EE: Civic Engagement

 Purpose: Citizens and residents improve community well-being by participating in local decision-making and volunteering with community organizations

Example Actions Measured:

- Adopt a policy to encourage diversity in local government appointments to advisory boards and commissions.
- Provide young people with opportunities to participate in civic activities.
- Adopt inclusive public engagement guidelines for local government agencies and departments.



EE: Civil & Human Rights

 Purpose: Respect, protect, and fulfill the civil and human rights of all members of the community.

- Demonstrate that all police-related civil and human rights complaints in the past 3 years have been investigated and violations redressed in a timely manner.
- Establish an independent civil and/or human rights commission to ensure access, equity, and inclusion.
- Operationalize the local government's civil and human rights polices in programs, services, and operations.
- Establish an office within the jurisdiction with the authority and capacity to investigate civil and human rights complaints.



EE: Environmental Justice

• Purpose: Ensure no neighborhoods or populations are overburdened by environmental pollution.

- Conduct a comprehensive environmental justice assessment.
- Adopt an environmental justice or social equity plan that includes strategies to reduce negative impacts and burdens to low-income populations and persons of color.
- Incorporate environmental justice criteria and priorities into zoning, land use planning, permitting policies, and development of new projects.
- Implement projects to reduce exposure to contaminants and risks associated with environmental justice sites.



EE: Equitable Services & Access

 Purpose: Establish equitable spatial access to foundational community assets within and between neighborhoods and populations.

- Adopt an equity plan that evaluates current conditions in the community and establishes targets to improve equitable access and proximity
- Provide advanced equity, inclusion, or cultural disparity training for local government staff.
- Publicize efforts to improve equitable access and proximity to community facilities, services, and infrastructure.



EE: Human Services

 Purpose: Ensure that essential human services are readily available for the most vulnerable community members.

- Adopt a human services plan designed to guarantee that basic human needs are met in the community.
- Support the provision of high quality, priority human services in coordination with non-governmental service providers.
- Upgrade existing facilities or build new facilities to better provide needed human services.



EE: Poverty Prevention & Alleviation

 Purpose: Alleviate the impacts of poverty, prevent people from falling into poverty, and proactively enable those who are living in poverty to obtain greater, lasting economic stability and security.

- Adopt a community-wide plan to reduce poverty.
- Establish or support programs that reduce the costs of basic needs for low-income households.
- Create programs to improve employment opportunities for lowincome individuals by strengthening hard and soft work skills.
- Provide child development programs for children living at or near the local poverty line.




Health Equity Work

 - We're Out Walking




New Climate Action & Resilience Plan Development
