Simply put, the job of a local government manager is nearly impossible by design. Demographic change is afoot at the national level, seeping into our gentle burgs and counties, creating both a true crisis of direction and questions about the role of government. Politics is the way we analytically evaluate values, and changing values create a changing political landscape. As elected bodies fracture, treating your staff fairly and innovating in your economy become harder and harder. You will have better luck building an animal shelter than a homeless shelter and nobody even questions the inhumanity in that perspective.

Add to this that those very employees are often under fire, figuratively and, sadly, literally. Our world is one where the shootings at Sandy Hook and Virginia Beach are fact and there is no trend nationally or locally that looks to change that. Public safety has become an awkward balance of serving a community which films your every move as a law enforcement officer because too many of them think "you" are the risk.

So here you are. You are the person who is responsible to make some sense out of this and make some progress. Your span of responsibility is nearly infinite and your span of control is minute. The people you answer to disagree at a fundamental level but each feel they have the mandate of the voter. So, in a cheesy announcer voice, you hear "At times like this, I take VLGMA".

Though it is true that VLGMA offers some technical know-how at our conferences (stormwater, broadband, legislative updates and the like), its real purpose is to give you strength and tools to sustain yourself and your community. It gives you mentors, coaches and contacts that help on the worst of days. Most importantly it gives you the emotional power to be an effective convener of a solution-finding processes.

Problems transform from "insurmountable challenges of the offices" to "real world struggles that you can focus the community and elected body around" not because of your problem-solving skills but because of your leadership. VLGMA seeks to grow that leadership and to help transform issues from intractable differences to solvable problems around which a consensus can be built.
