I crafted similar messages to the entire Chesterfield workforce over the past weekend as I wanted all employees to know how important they are and how much we try to ensure a safe workplace. More importantly, how they all need to know how important that they take care of themselves and offer the comforting and supportive role to fellow employees.

Those actions can help create a great and safe workplace, but as evidenced on May 31, there is no guarantee that even doing all the right things is 100% in preventing tragedy from arising. It's the world we live in and it's our faith that we must rely upon as the ultimate source of strength to watch over us.

I've given many speeches to many groups over my tenure as County Administrator, but perhaps the most poignant and real speech I've given is where I describe all the times I've had tears in my eyes. Sometimes it has been tears of joy, as it was when a 90 year-old mother of a disabled son told me she could die in peace knowing that the county would look after her son. Other times tears from sorrow (with some of those emotions containing anger). May 31 was the sorrow (mixed with anger).

We all mourn and grieve differently, but we all need to recognize that peer support is universal. Sometimes that support can be a friend to friend in our profession as we've comforted each other from afar. For others in our workforce, it can range from employee-employee, employees in small groups, employees with in-house or EAP contracted resources in person or via phone call.

Regardless, employees look to us as leaders to set the tone and our care and attention to our employees and the citizens that visit us is a honest conversation yesterday, today and tomorrow. I have greatly enjoyed my tenure and getting to know many of you better over the past year.

From ICMA Executive Director Mark Ott: It is difficult to put into words the conflicting emotions that are coursing through me as I try to process the horrific scenes from Friday's massacre.



As stewards of public trust, we work daily to strengthen and secure communities; which made news of the malicious attack in Virginia Beach particularly painful to watch, and difficult to comprehend. I am frustrated and angry by the frequency of these episodes, and heartbroken that such an inhumane act occurred in a municipal building. More than anything, I am grief stricken over the loss of your dedicated colleagues. I understand some were with the city for many years. Undoubtedly, you are grappling with your own emotions and unanswered questions, and while the road ahead will be challenging, it is one you are equipped to navigate.

I'm sure we've all heard the phrase, *Failing to plan is planning to fail*. However, the Institute for Crisis Management (ICM) estimates that *only 50 percent* of all organizations have a crisis communications plan in place to guide them *when*, not *if*, a communications crisis emerges.

Public entities face a variety of exposures that could lead to a communications and reputational crisis. From land use issues, data breaches or cyber attacks, personnel or management issues, legal actions, safety violations, natural disasters – and more – it is vital for entities to prepare and plan now for a crisis that could happen tomorrow.
