When I was promoted in 2004 from Finance Director to Deputy County Administrator in Hanover, I began to slowly transition from my roles in the national Government Finance Officers Association (GFOA) and its state affiliate VGFOA to ICMA and VLGMA. Many of us started our public sector careers in a technical profession and most likely were affiliated with similar national and state associations. Organizations like GFOA and VGFOA is where I met many state and

national colleagues; some for lifelong friendships. However, whether time or budgetary constraints, I needed to pivot to ICMA and VLGMA.

I had the honor of being VGFOA President in 2002 and GFOA Board member in 2005; Virginia's first representative since 1966. When I interviewed for GFOA President in 2008, there had never been someone from Virginia in its 100-year plus history. During my interview I raised the issue that it seemed odd that Virginia with the most AAA-bond rated localities and many other financial accolades would never have had a president. Perhaps such Virginia boastings didn't help me get the role. However, I still advocated for Virginia to take its rightful turn at the helm.

Chris Morrill, first started to break down this barrier as he was elected President while serving Savanah GA, then came to Roanoke as City Manager soon afterwards. However, May 21 will be a significant date for Virginia and its national recognition for a professional association. Terry Stone, Hanover County Public School's Assistant Superintendent of Business and Operations will begin her tenure as GFOA President and the first from Virginia. I don't know how to validate, but I would venture to say that GFOA is the last of the major national governmental professional associations for which there hasn't been a home-grown Virginian to lead it.

Terry is home-grown, and I've had the pleasure of working with her since 1990 in both my Hanover and Henrico roles. I've had a front row seat in seeing one of the most talented and versatile people take on life's challenges to get her college degree and then her CPA while working full-time. There have been many that may have helped mentor her along the way, but she is such a quick study and leader, that mentors turn into mentees around her. She used her "free time" to become an elected School Board and then Board of Supervisor member in King William.

She has mentored many of today's all-stars of governmental finance and future leaders. I wish her nothing but the best in her president role. Please also do the same directly, or through your finance staffs that see her regularly. And also continue to be both a mentor and a mentee in our life-long learning quest.

PIEworks: Process, Improvement, Innovation, and Engagement

In 2016, the State of Ohio began a program called Lean Ohio. Under Governor Kasich's administration, there was a push to eliminate waste from government and rethink existing processes. As a part of this program, public employees from around the State could leverage the Local Government Innovation Fund to partake in a weeklong course known as LEAN Ohio Bootcamp. During this five-day course, students learned the basics of Lean such as SIPOC, Pareto Principle, 5S, Poke-Yoka, Process Mapping and more. The City of Dublin found value in this training and hosted an event at a local venue with 13 additional staff members to learn the fundamentals of Lean.
