Statement of Membership Eligibility (according to the Bylaws of the National Association of County Administrators)

***Block Membership:** State County Administrator Associations shall qualify for block memberships to NACA when 100 percent of the state association members join NACA as corporate, associate, or honorary members. State associations shall be eligible for a dues discount (\$50 per person) from NACA when block membership is verified.

****Corporate Membership:** A county administrator, who is defined as that individual and/or their assistant(s) and staff, regardless of official title, who is directly responsible to the governing body or elected chief executive and whose official duties are primarily devoted to general management or administration of county activities may become a corporate member of the Association upon written application to the secretary/treasurer and approval of the regional vice-president for the applicant's region, and payment of any applicable dues.

*****Associate Membership:** Any person, not eligible to be a corporate member, having a professional interest in the objectives and programs of this association may become an associate member, upon written application to the secretary-and approval of the regional vice president from the applicant's region, and payment of any applicable dues.

Affiliate: Any organization or individual having an interest in the objectives and programs of this association may become an affiliate member upon written application to the secretary and approval by the president after finding that the applicant's interests will support the purposes of the National Association of County Administrators.
