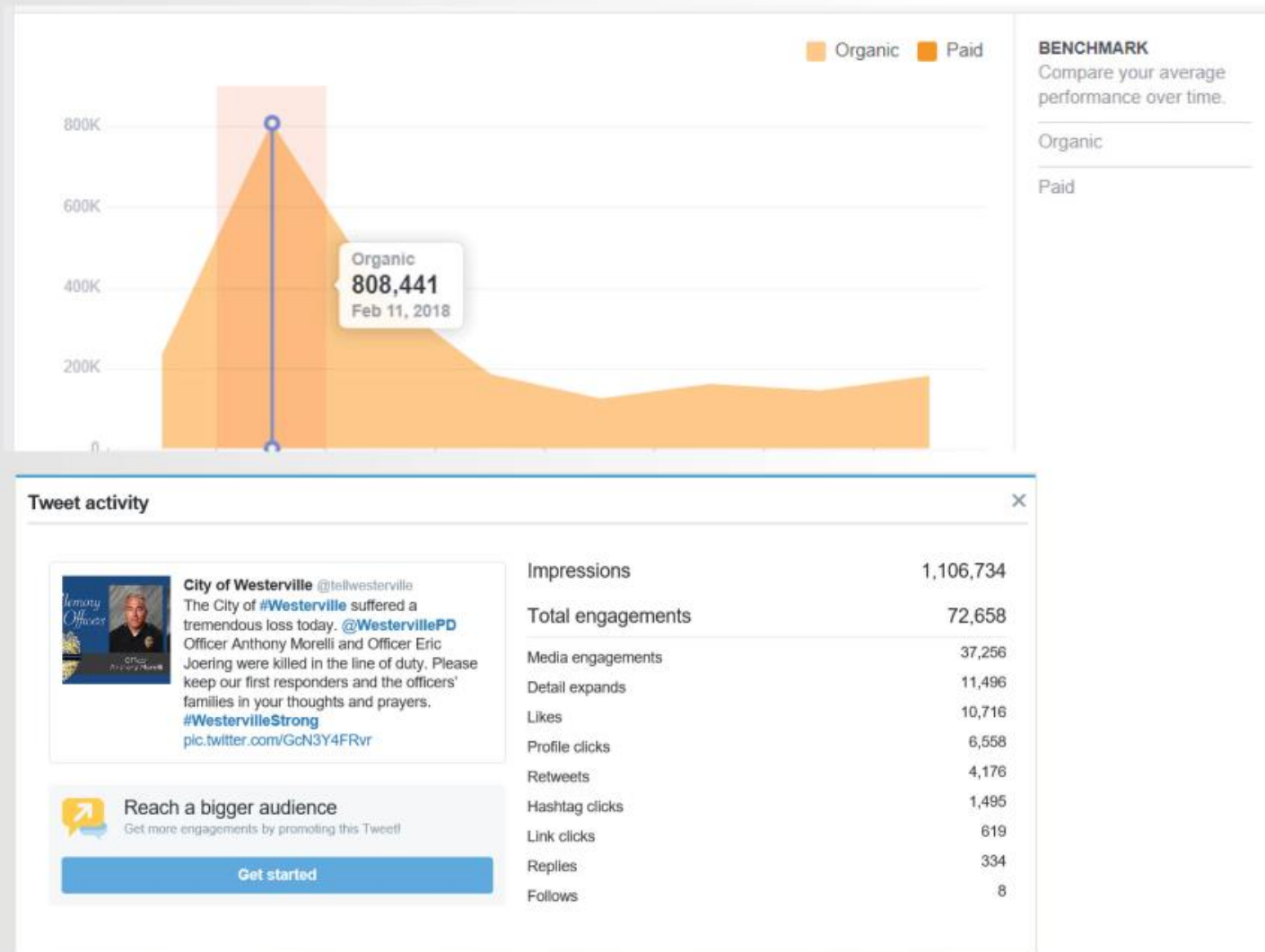

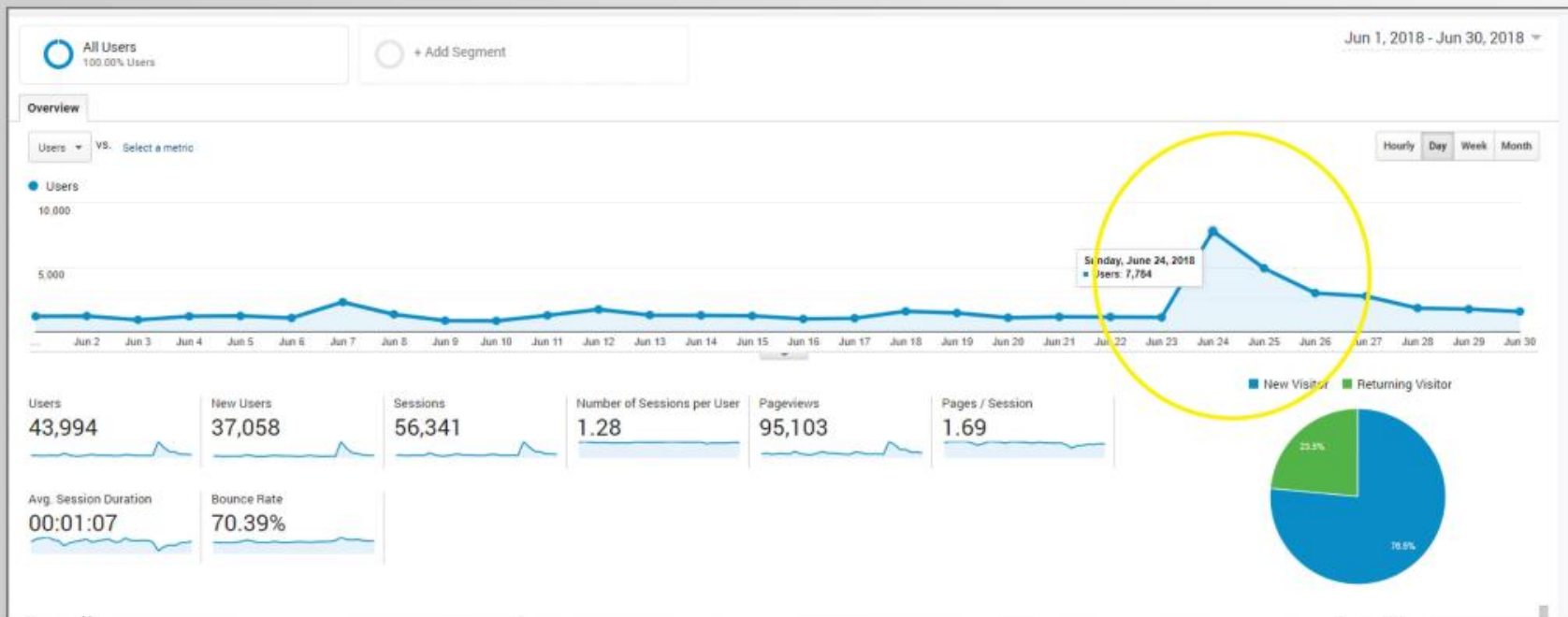

Kirtland man pleads guilty

Admits to hit-and-run crash that killed Mentor police officer

A 25-year-old Kirtland man has admitted to a hit-and-run

crash that killed Mentor police officer Mathew Mazany.

Brian Anthony pleaded March 1 to second-degree felony aggravated vehicular assault, third-degree felony failure to stop after

an accident and misdemeanor charges of operating a vehicle under the influence of alcohol, a drug of abuse or a combination of the two; and failing to proceed with due caution, and/or failing to change lanes when approaching a stationary public safety vehicle displaying emergency lights.

A sentencing hearing in front of Lake County Common Pleas

Court Judge John P. O'Donnell is scheduled for April 12.

Anthony faces a maximum of 11.5 years in prison. The aggravated vehicular homicide charges carries a minimum mandatory prison time of two years.

Bond has been revoked. Anthony has been in jail in lieu of bond since his arrest.
