Introduction

This TFG Special Report identifies potential federal funding opportunities to support activities that help communities combat the opioid crisis, as well as helpful tips to make the best use of available funding. The report includes 39 grants across different federal departments and information on how local government officials can best use the tools available to them to reduce the effects of the opioid crisis in their communities.

In September 2019, the Trump Administration [announced](#) more than \$1.8 billion in funding to states to continue the Administration's efforts to combat the opioid crisis by expanding access to treatment and supporting near real-time data on the drug overdose crisis. Along with this, the Centers for Disease Control and Prevention announced more than \$900 million in new funding for a three-year cooperative agreement with states, territories, and localities to advance the understanding of the opioid overdose epidemic and scale-up prevention and response activities, releasing \$301 million for the first year. This funding will likely be used for future fiscal year (FY) 2020 program solicitations, most of which have not been released and therefore are not included in this special report. TFG will keep you apprised on the release of these new and additionally funded programs as they are developed.

Funding Opportunities

There are approximately 39 grants and funding opportunities available to address the opioid crisis in communities. This report groups those opportunities into three categories to make it easier to understand what is available and who is eligible to apply for each program. The categories of grants include:

- Municipal Eligibility including programs for which local agencies, state, and non-profits can apply.
- State Eligibility including programs specific to state governments.
- Non-Profit Eligibility including programs for which non-profits can apply.

Municipal Eligibility Grants

Local governments, states, and non-profit organizations are all eligible to receive funding under the following programs.
