better job of supporting and learning from each other as a professional peer network and VLGMA can help facilitate, nurture and enhance that peer network while at the same time continuing to provide outstanding professional development training opportunities and networking. What we've heard so far has been invaluable. Here's a couple of take aways so far which I plan to bring to the Board and the Professional Development Committee in the next few months for discussion.

First, every region is different; it has its own character and feel. In some regions the managers are friends and mutually supportive colleagues, in others it is fairly clear to me that some of the managers aren't guite sure who else is even in their district and in at least one district, relations between the managers and the communities they serve seem downright hostile. So the first take away lesson - one size definitely does not fit all, which reinforces for me the belief that in order to do a great job in supporting our diverse membership, we need to have a customized relationship with each region. How might we do that?

Here's the second major take away which came from my meeting with

Lynchburg - we need to examine the job description (a polite way of saying we need to write one) for our Support Coordinators. We need to train them, support them and count on them to be our eyes and ears in each region. They can be our two-way conduit for support, suggestions and special needs. We have a tremendous resource and structure that I think we are not fully optimizing. I believe this one idea, if done properly, is transformational and the good news is it's one of a dozen or more we've received so far.

In the coming weeks, I would encourage each of you to share your thoughts and ideas with me or any of the Executive Board Members or Officers. Please call, email or better yet attend a regional managers meeting. Thank you for all you do on behalf of the citizens of Virginia, our profession and our organization. UnTagging the Town: Blacksburg's **Murals Bloom Amid Graffiti**

Over the past handful of years, Blacksburg noticed a trend in and around downtown that wasn't resulting in a positive image of the community. Graffiti, and more particularly tags, were being painted throughout the area on walls, buildings, electrical boxes, fences, and any surface that lent itself to the medium. To address the problem, town staff began working with local businesses and homeowners to utilize volunteers to rid their properties of these nuisances. This public private partnership was born out of the necessity to remove unwanted tagging from the community without a budget or analogous with what the "Lean In" ordinance requiring the cleanup. This was done through the Town's Housing

will begin. To help ease the pain of the coming hectic time of transition, the Certificate program welcomed back Dr. John Nalbandian. His visits allow everyone involved in the program to take a quick, refreshing breath in order to add broad perspective to our work.

Dr. Nalbandian lectured two classes for the Certificate, led a lunch discussion with students, and dined with alumni in Roanoke. His lectures focused on the administrative and political sustainability of local government policies. As a former mayor with a long association with local government professionals, he understands both the management and political aspects of
