Do not legislate by anecdote

With the new year comes rekindled hope that things will get better, and those who hold much of

our localities', states', and nation's future in their hands will exercise enlightened leadership to plot a prudent course for the future.

In that vein, I heard a one-line statement not long ago that resonated strongly with me, and I sent myself an email to use it in an upcoming "take". It is...

"Do not legislate by anecdote."

While it is always important to add the human element to important discussions, and relate a policy or programmatic issue to how it will impact individuals in the short and long runs, we have all experienced "legislation (decision-making) by anecdote". It also seems there is more and more going on all the time.

Decisions are made to take action, enact a new or revised policy, or even pass a law based on individual/one time events and limited or no other input. Events that may impact a very few or actually be of minor consequence are accelerated to a level of prominence by any number of methods including social media, a noisy talk-show host, or noted op-ed writer, just to name a few. Legislators, regardless of governmental level, feel immediate and intense pressure to "do something" without thorough analysis, consideration of precedent, or debate.
