City of Charlottesville Emergency Preparedness & Safety Strategy Committee on Safety and Emergency Preparedness (CSEP)

The City of Charlottesville Committee on Safety and Emergency Preparedness (CSEP) is charged with creating the framework for City's Emergency Management programs and practices. CSEP's mission is to reduce community, citizen, and employee vulnerability to hazards and to improve community resilience in the face of natural and man-made disasters. CSEP takes an all-hazards, full-spectrum approach to emergency preparedness, by integrating planning, preparedness, response, and recovery efforts.

The City of Charlottesville is vulnerable to a variety of natural and human-caused emergencies and disasters. A planned and coordinated response by the City of Charlottesville can save lives, protect assets, and more quickly restore essential services. The CSEP seeks to build upon daily operating concepts and inter-departmental and community relationships to ensure that skills and resources are matched to the needs of the community, our citizens, and our employees in times of emergency or disaster.

The CSEP is chaired by the Fire Chief who serves as the City's Coordinator of Emergency Management. The Committee provides programmatic oversight, policy direction, and coordination of Emergency Management efforts for the community, citizens, and City government employees. Representatives from the following departments will serve on the CSEP: City Manager's Office, Procurement/Risk Management, Fire, Police, Public Works, Social Services, Information Technology, and the Regional Emergency Management Coordinator. The Emergency Management Program is designed to accomplish the objectives outlined below.

CSEP responsibilities and objectives include:

- Develop and maintain the City's Critical Incident Management Plans.
- Develop and maintain hazard-specific critical incident plans.
- Complete an annual Hazard Vulnerability Analysis (HVA).
- Coordinate the development of Continuity of Operations Plans (COOP) for all City departments.
- Coordinate City Staff education and training in the National Incident Management System and Incident Commend System to ensure essential Emergency Management capabilities.
- Organize and implement disaster tabletops, drills, and exercises.
- Coordinate the development, implementation, and evaluation of City-wide safety programs.
- Coordinate the emergency community notification system.
